This exemption is applicable only if the producer is selling those agricultural products that he or she has produced. The mixing of products purchased from another producer with products raised by the seller will result in all sales becoming taxable. By signature on this form, I hereby understand that I will be liable for sales tax on all of my sales if I sell any agricultural products that I have not grown or that are not in their original state.
